Upon completed sale Individual will receive a commission of \$500.00 per Incred-I-Box either size and any option package sold or 2. Accumulate points for each S per Incred-I-Box either size and any option package sold at a rate of 1000 points per Tiny Home sold. After accumulating a total of 20,000 points individual will be provided one (1) Standard 8’ x 16’ Incred-I-Box. Points will only be available to use for the Standard 8’ x 16’ Incred-I-Box, and cannot be accumulated beyond a total of 20,000. Individual may at their choice continue to earn points after each 20,000 earning a Standard 8’ x 16’ Incred-I-Box. Individual agrees to sign a contract for an Independent Contractor / 1099 employee upon acceptance by ITH.

**Commision Payment & Points issued time frame / method**

Individuals opting for a \$500.00 commission per Tiny Home sold, will be paid only after a fully signed contract with payment in full has been received. Individuals opting for the Points per Tiny Home sold, points will only be issued after a fully signed contract with payment in full has been received. Commissions will be paid within the 1<sup>st</sup> 14 business days of the month following a completed sale. Points will be awarded paid within the 1<sup>st</sup> 14 business days of the month following a completed sale.
